a) **Wi fi project i) Wifi update ii) SWPC vote to continue/ discontinue with Wi fi Project into Yr2**

i) & ii) combined, Cllrs had looked at the Wi fi report / responses to qus asked and wi fi usage for Yr 1. SWPC considered the costs associated with continuing with Wi fi and further developing this project and decided that in view of there not being available local grant funding and insufficient demand for VH wifi , SWPC agreed that this project should be discontinued. Clerk asked to thank Mr Chapman for all his hard work setting up / maintaining wi fi in the vhall over the last yr. Clerk to advise SKDC that it is withdrawing from the project and to also cancel the contract with BT, once it has run for the full year.

b) **Church Lane / High St flash flooding update, Cllr Jolley** Cllr Jolley had written a letter for SWPC approval, to send to the relevant bodies ie. LCC, UWIDB, Anglian Water and Buckminster Estates to work together with SWPC to fix this problem. SKDCllr Webster passed over the response to the initial letter sent to LCC by SWPC outlining the issue. Cllr Jolley agreed to review this and incorporate his response to this in the letter to the various bodies. Cllr Jolley to forward letter to clerk for SWPC approval / posting.

c) **Monthly play area inspection, Cllr Oldfield** Cllr Oldfield had completed the inspection, skate park ramp is starting to lift slightly in places due to warping, to continue to monitor. Annual Rospa inspection due in August.

i) Breedon Aggregates (PL/0074/16 (S68 /16) - Proposed Eastern and Western Extensions to South Witham Quarry, the completion of operations in the existing quarry together with the relinquishment of the permitted area to the north of Mill Lane granted under a historic Interim Development Order

SWPC agreed to set up a working committee to look into this planning application fully, Cllr Jolley to chair, with Cllrs Parish, Fowler, Lansdowne and possibly Ashton to assist (Cllr Ashton absent, so to check with him outside of PC meeting). Neighbouring villages of Thistleton, Sewstern and Wymondham to be contacted to see if they would like to be involved. *Post mins note, also Colsterworth and North Witham.* Clerk to establish interest and obtain contact details of those to attend to advise of first meeting. SWPC agreed to request an extension to the deadline for comments set by LCC to 30/9/16, clerk to sort. SWPC to arrange a Public Meeting in due course for villagers to attend and Breedon Aggregates representatives to come along and answer questions. To take place mid Aug approx. and prior to SWPC's submission of comments to LCC. A resident present advised that the Open Spaces Society had already objected to the planning application in terms of footpath issues (see LCC website for details). He is to attend the Lincs Action Forum this week, as this application is on its agenda to discuss the footpath issues, to update SWPC afterwards.
